# NEW LICENSE APPLICATION PROCESS FOR BAHRAINIS

## **Application Requirements:**

**NHRA only accepts complete application submitted through the online system MEHAN. A license application is considered complete if the following documents are required:**

Invitation: an invitation should be done by the facility through the electronic system (munshaat), the professional will receive an invitation email with a link to MEHAN. then he should sign up and complete the new application request.

(Note: Bahraini may apply for new license without an invitation and grant a license under non specified facility).

The following documents will be (but not restricted to) requested:

1. Verification report (from dataflow or Quadrabay): (If applicant has work experience and license outside Bahrain only). In such cases the verification report must verify both the work experience and license). The link to Dataflow and Quadrabay may be found on NHRA's website under useful links.
2. Good standing certificate from licensing authority of last country of practice (If applicant has work experience outside Bahrain only).
3. Curriculum Vitae (C.V).
4. Copy of attested education certificate.
5. Work experience certificate/s (if the applicant has worked out of Bahrain).
6. Copy of the valid licenses (if the applicant has worked out of Bahrain).
7. Copy of CPR.
8. Copy of valid passport.
9. Health fitness certificate issued by a licensed health facility in the kingdom of Bahrain.
10. Passport size photo with white background.
11. Application submission fees 20 BD (this is not including license fee and its nonrefundable).

## **Process:**

Once a decision is reached, the applicant will be notified through the online system regarding the decision.

- If the application is approved, a notice to pay will be generated through the online system.
- If an application is rejected, the reason for the rejection will be detailed in the online system.

- If the applicant needs to pass the licensure exam, the eligibility code will be sent through the online system. The applicant must upload the exam result through the online system (please refer to Licensure Examination Guide for further details about the examination).

Once the payment is made online, the electronic license will be issued in the applicant's account in the electronic system **MEHAN**
